DEED OF TRUST

THIS DEED OF TRUST is made on this the 3rd February 2022 at Bangalore by Mr. Narayana Reddy Ravindra s/o Mr. Basappareddy Narayana Reddy aged about 65 years, residing at #61, SeetharamPalya, Mahadevapurapost Bangalore 560048 and Mr. Naveen R S/o Mr. Ravindra Narayana Reddy aged about 37 years residing at #61, SeetharamPalya, Sonnenahalli, behind SAP labs, Mahadevapura Bangalore 560048 hereinafter called "the Authors of the Trust."

Whereas the Authors of the Trust is desirous of establishing a trust to administer Schools, Colleges, Pre Schools, Day Care, sports institutions and other educational Institutions including Medical / Engineering courses, vocational courses, Training center, job oriented courses and other value added service institutions and for carrying on charitable activities for the benefit of the general public, weaker section of societies and to rehabilitate them by establishing such coordinating centers and such other institutions for the benefit of weaker sections of the society without any distinction to caste, race and religion.

And whereas the authors of the trust have set up of Rs. 10,000 (Rupees Ten Thousand only) for the purpose of the trust and declare the constitution of the trust with the said amount as the Trust fund to carry out the purpose of the Trust.

NOW THIS DEED WITNESSETH AS FOLLOWS:

1. The Trust hereby established shall be known as "BNR Education Trust."
2. The registered office of the Trust shall be at Sy No 35, Municipality No 372 Graphite India Road, Sonnenahalli Village, K R Puram Hobli, Bengaluru-560048 or such other place as the Trustees may in future decide.
3. The author of the trust makes over the said sum of Rs. 10,000/- (Rupees Ten Thousand only) mentioned above in favour of the trustees upon Trust subject to the power and provisions hereinafter declared and specified concerning the same. The Author retains the option to further make such investments into the funds of the Trust as he deems fit.
4. The Trust property shall consist of trust fund as mentioned above and all funds, properties, movable and immovable, acquired, accrued and added hereafter to the trust in whatsoever manner.

- d) To open a research center with all types of equipment's which is useful for all Arts and Science students and to enhance the research activity of basic sciences.
- e) To establish within India and abroad schools, colleges and hostels other educational institutions social and literary institution.
- f) To propagate promote and preserve the Indian culture, Traditional crafts, Indian Philosophy, Yoga and Music and Fine Arts.
- g) To arrange Literacy association educational conferences, Environmental conferences (Seminars), lectures and debates.
- h) To provide regular coaching in Sports and Games and organizing periodical camps in Sports and Games, so as to enable the children to participate and achieve in the state, National as well as international level sports competition.

- i) To provide financial assistance to the hostel inmates who will participate in the State, National and International level sports competition.
- j) To aid establishments and all types of educational institutions for the benefit of the public at large, provide consultancy services in the field of education, and for running of such institutions for the cause of furthering education amongst the public at large.
- k) To publish periodicals, book, journals, newspapers, bulletins, leaflets, and newsletters, etc., devoted to the promotion or furtherance of the cause of education sports culture.
- l) To assist any institutions formed for the advancement of education or culture and which is recognized as an activity of a public Trust. To promote and take-over affiliate institution having similar objects.
- m) To do or cause to be done all such lawful things as are in accordance with the spirit and principles of the objects of the Trust (or) which is conducive to the attainment and pursuit of the aim and objects of the Trust.
- n) To promote Arts, Culture, Fine-Arts, Music and sports by organizing and arranging suitable activities.
- o) To provide Guidance and Counselling for the benefit of students and unemployed youth. To establish and maintain a boarding house for the students who receive education on the school. To establish hostels, student homes run free or subsidized for the students and weaker sections of the society.
- p) To organize, arrange and promote suitable activities for the welfare and development of the society and community.
- q) To start schools with the curriculum of IGCSE, NIOS central Board of Secondary Education(CBSE) with computer practical facility, all other lab facilities, NCC, NSS, sports and cultural events.
- r) Each of the above objects shall be independent of the other and none of the above objects shall involve the carrying on of any business, trade or any activity for profits.

- s) It is further declared that the Trust shall not carry on any business, trading activity or activity for profit. The aforesaid objects shall be provided to the beneficiaries without discrimination of caste, creed, colour, sex, religion.
- t) To organize and arrange exhibitions, functions, seminars, cultural entertainment events, competitions, benefit shows and similar other programs such as training camps, field trips, lectures, conferences etc.
- u) To work and promote educational standards, impart basic, supplementary and adult formal and non-formal education programs for the school drop outs, transit schools for the street children and child labourers and adults and financial literacy programmes and also run model education training schools and coaching centers at various levels.
- v) To publish periodicals, magazines, newspapers and bulletins as part of awareness programmes for the weaker sections of the society and also for the general public.
- w) The Funds and the Income of the TRUST shall be solely utilised for the achievements of its objects and no portion of it shall be utilised for payment to the Trustees by way of profit, interest dividend etc.
- x) It is further declared that this Trust shall exist solely for educational and social purposes and not for purposes of profit. Any activity of the Trust will be treated as Trust performance and the accounts there on will be brought into the Trust account.
- y) To promote welfare programs for improvements of living standards of schedule caste, schedule tribes, other backward classes and minority youths by providing coaching to appear for the competitive examination and to offer consultancy in formation of NGO, various registration formalities in obtaining 12(A), 80(G) and Income Tax Act, FCRA etc. To offer consultancy in raising funds to NGO's from central and State Governments and also from overseas sources.
- z) Generally, to do all other things as are deemed incidental or conducive to the attainment of the above objective.

TRUST IRREVOCABLE:

8. The Trust created by the Authors of the Trust under this Deed is not and shall not be revocable at the instance of the Author of the Trust or by his successors at any time under any circumstances.

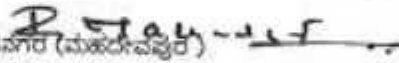

CHAIRMAN OF THE TRUST:

- There shall be a chairman elected among the Trustees themselves who shall be responsible for the day-to-day activities of the Trust, subject to the supervision of the Board. The powers and duties of the Chairman shall be defined by the Board of Trustees from time to time. The Chairman shall preside over meetings of the Board of Trustees and shall hold office for a period of Five years at the first instance and will be eligible to be re-elected as a Chairman for any number of times.

MEETINGS OF THE BOARD:

- The Board of Trustees shall meet from time to time as and when necessary to transact the business of the Trust. The meetings held by the Board of Trustees shall be presided by the Chairman and, in his absence, any Trustee chosen among them as the Chairman at the meeting. The Board shall prescribe the procedure to be adopted in the matter of convening the meeting, time, place, etc.
- Any member of the Trustee may convene the meeting of the Board of Trustees by communicating a notice of the meeting on other Trustees in writing either by sending it by post or by personal delivery.
- All decisions of the Board of Trustees shall be by simple majority of the Trustees as are present and voting in a duly convened meeting except regarding transfer of any property of the Trust and amendments to the Trust Deed for which at least $3/4^{th}$ of the members of the Trust shall vote in favour of the resolution, for it to be effective. If an equal number of votes is registered for or against a resolution moved or proposed in the meeting, the Chairman shall have a second or Casting Vote.

RESOLUTION BY CIRCULATION

- If a resolution intended to be adopted is deemed by the Chairman of an urgent nature, it may be circulated in writing, together with an explanation in regard to its purpose and content to all the Trustees with a request that their view on the resolution may be communicated to him a date, which he shall specify therein, and if by such date, no objection is recorded by a majority of Trustees duly convened, and it shall not be deemed invalid by reason of want of notice or any other cause whatsoever.

ACCOUNTS:

17. The Board of Trustees shall cause and keep true accounts of the sums received and expended on behalf of the Trust which shall be closed at the end of every financial year.
18. The year of account shall be the financial year commencing from 1st April and ending 31st March.
19. The Trustees shall each year issue a report setting out the accounts showing the income and expenditure of the Trust for the preceding year not later than six months from the end of the preceding year of accounts.
